INTRODUCTION

This manual provides installation operation, service, and parts information for the Adjustable Duplex Tip Holder. The Holder is used on 4700 machine cutting torches to permit two simultaneous, parallel cuts 1-1/4 to 12 inches apart. It can be used to cut material thickness up to 3 inches. It permits concentric circle cuts when the torch is mounted on cutting machine equipped for circle cutting.

The Holder may be used in a Series 4700 torch with any 3/4 inch 3-land; CONCOA/AIRCO style cutting tip.

The Holder's three major parts are: a torch head connector with a tip nut; a 90 degree cutting head on a fixed arm (attached to the connector); and a similar head on a swivel arm. A locknut sets swivel arm to fixed arm.

INSTALLATION

- a. Install required tips in Holder heads and tighten tip nuts with proper wrench.
- b. Install holder in torch loosely, position fixed arm head to desired position and tighten tip nut with wrench. Do NOT loosen lower nut for fixed arm adjustment; use tip nut.
- c. Slightly loosen bottom locknut just enough to adjust swivel arm to desired position and retighten (locknut also compresses 0-rings to seal the swivel joint).
 - d. Position tips over plate edge so both cuts will start simultaneously.

OPERATION

Adjust gas pressure regulators the same as for standard tips BUT add 5% more cutting oxygen pressure. Avoid small flames which may cause tip overheating and backfiring.

CAUTION

DO NOT adjust arms or loosen locknut while gases are flowing.

Avoid heat deflection onto swivel joint.

SERVICE

IMPORTANT

Checking or repair of this equipment may be undertaken only by persons experienced in similar equipment repair.

CAUTION

Shut OFF gas supplies and remove Holder from torch before attempting service.

Maintenance Tips

- a. Keep swivel joints clean.
- b. If joints leak, check 0-rings for damage or wear. Replace if necessary.


Parts Replacement

Use parts illustration to aid in parts replacement disassembly:

- a. Remove locknut to remove swivel arm.
- b. 0-rings should be seated in three shoulders in bottom swivel shaft cavity. **DO NOT** lubricate PTFE 0-rings.
- c. Remove mixer nut (below tip nut) for replacement of torch head connector parts or fixed arm assembly.
 - d. Be sure parts are clean before reassembly.
