The 420 Series SilcoNert® treated, six-port cylinder regulators are intended for pressure control of reactive or corrosive calibration mixtures or pure gases in applications where an extremely inert wetted finish is required. The proprietary nonreactive amorphous silicon finish is significantly more inert than 316L stainless steel and ideally suited for Hydrogen Sulfide, reduced Sulfur, Mercury, and PPM to PPB calibration mixtures. In a six port configuration, the 420 Series regulator is suitable for sole pressure control in applications that can tolerate minor fluctuations in outlet pressure due to diminishing inlet supply or with gases stored at pressures below 500 PSIG (35 BAR).



#### **Six Port Configuration**




